
Hello, and thank you for your interest in applying for a grant from the Catonsville Women's Giving Circle. As you consider your application, please be aware of the following:

## Catonsville Women's Giving Circle 2024 Grant Application

The completed application must be emailed by August 15, 2024. Grant applicants must be IRS-designated 501(c)(3) nonprofit organizations located in / serving citizens of the Catonsville area. All successful grantees must sign a grant agreement regarding the use of funds and project reporting at the time of receipt of funds, as well as a summary of the project after year's end via a survey link provided. Non-compliance with the terms of the grant may influence future application decisions. In the past, the grant requests have ranged from\$500.00 to \$3,000.00.
